#### **OUTLOOK AND STRATEGY**

(from the JPMorgan Asia Equity Dividend Fund Monthly Commentary dated January 31, 2021)

Markets – Asian markets started the year strongly, driven by expectations of a synchronized global recovery as COVID vaccines are rolled out and due to another material U.S. fiscal stimulus package. Global volatility rose towards month-end due to some extraordinary retail investor activity in the US, while Asian investors were also concerned about domestic liquidity tightening in China. Growth outperformed value and high dividend this month.

Helped - Stock selection in financials and consumer staples.

Hurt – Stock selection in communication services and consumer discretionary.

Month in review

The Target Fund lagged the benchmark due to style headwinds.

On the positive side, stock selection in financials contributed the most. Hong Kong Exchange rallied on the back of record-breaking Southbound flows to the territory. Postal Savings Bank of China and China Merchants Bank also did well. The latter pre-announced positive results. Elsewhere, in consumer staples Tingyi performed strongly due to global short covering. The company continued to grow its noodles volume thanks to market share gains, and its beverage business has also entered a stable growth phase. Other top contributors include TSMC, which gained on a surprise capex hike and guidance.

On the negative side, stock selection in communication services and consumer discretionary hurt as stocks the Fund Manager did not own outperformed, for example Tencent, Alibaba and Meituan. Elsewhere, their overweight in Samsung Electronics detracted as it pulled back after the strong run in the previous quarter. Importantly, Samsung announced a special dividend and enhanced its payout policy for the next three years.

#### Looking ahead

How long COVID persists as a health risk is crucial for economies and financial markets. Medical developments could mean a path to normalcy is possible in 2021. However, the speed of vaccine rollouts differs greatly, and uncertainties still remain, especially in the near term.

A strong US growth trajectory due to large fiscal stimulus will be helpful for Asian economies and industries that cater to US demand. The path of the US Dollar from its currently low levels will also shape the environment for Asian equities.

Overall, valuations are now above average, but earnings revisions are positive across a broad range of sectors.

The Fund Manager maintains a diversified positioning in quality franchises, defensives, and value cyclicals for both income and growth opportunities. They remain overweight in technology and financials.
