

## OUTLOOK AND STRATEGY

### (from the JPMorgan Asia Equity Dividend Fund Monthly Commentary dated 30 September 2020)

Markets – Asian markets pulled back in September dragged by a correction in US tech, a strengthening of US dollar and a resurgence in global infection cases. Geopolitical tension continued as the U.S Commerce department considered expanding its supplier restrictions to cover China's largest semiconductor foundry SMIC. Growth continued to outperform value and dividend this month.

Helped – Overweight and stock selection in technology.

Hurt - Lack of eCommerce.

Month in review

The Target Fund underperformed the benchmark.

On the positive side, overweight and stock selection in technology contributed. Samsung Electronics outperformed on expectation of strong mobile phone sales and profit as well as memory pricing recovery. TSMC also continued to stay strong. Indian IT consulting names TCS and Infosys rallied as the sector benefited from a stronger US dollar. Other top contributors include athleisure textile maker Shenzhou as its latest strong results confirmed the vendor consolidation thesis. REITs also outperformed in a risk off environment.

On the negative side, lack of zero-yielding eCommerce exposures hurt again as Alibaba continued to gain. Elsewhere, energy name CNOOC fell on slowing demand prospects and weakening oil price. Indonesia big caps Bank Rakyat and Telkom Indonesia dragged because lockdown measures were re-introduced turning Indonesia to the worst performer over the month. Previous outperformer Hong Kong Exchange retreated despite robust IPO/ ADR returning pipeline.

#### Looking ahead

Parts of the world are seeing normalization in household mobility and spending although concerns regarding COVID's spread remain present in Europe and some emerging economies. China continues to stand out with growth expectations for the next two years and business surveys back to pre-COVID trend.

A weaker US dollar – typically positive for Asian equities could be seen in the near-term considering interest rate differential should remain low and US growth is unlikely to outperform the rest of the world.

Although market has rerated to average valuations level, corporate fundamental continues to improve with earnings revisions firmly pointing upwards and broadening out.

The Fund Manager maintains a diversified positioning in quality franchises, defensives and value cyclicals for both income and growth opportunities.

Over the month, the Fund Manager rotated some Chinese consumer names while reducing select banks and telecom exposures.
