INVESTMENT OBJECTIVE AND STRATEGY

The Fund seeks to achieve long-term capital appreciation by investing all or substantially all of its assets in an equity collective investment scheme that invests mainly in equity securities of companies predominantly involved in providing financial services.

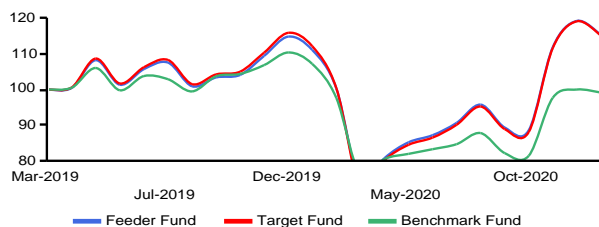

Standard Deviation measures how widely dispersed the fund's returns are away from the average return of the fund.

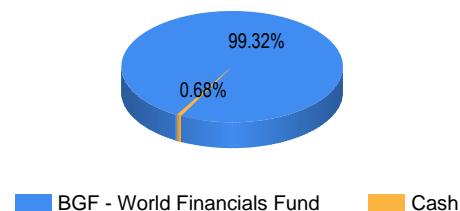

OUTLOOK AND STRATEGY

January 2021 Market Review:

January was a volatile month for equity markets. Most developed markets started strongly but gave up their gains by the end of the period. Emerging Markets significantly outperformed, with robust economic data supporting share prices. The market looked through lockdowns in various countries at the start of the year as vaccination programs began being rolled out and further monetary and fiscal stimulus was anticipated.

Volatility resumed when concerns around the supply of vaccines to Europe were raised and fears that the coronavirus would continue to disrupt the global economic recovery.

Democratic victories in both of Georgia's Senate runoff election marked the control of a single party over all branches of US government, the White House, the House of Representatives, and the Senate.

As equity markets fell, government bonds bounced, with the 10-year Treasury ending January above 1%.

The MSCI ACWI fell -0.45% in January with Energy, Communication Services and Health Care the top performing sectors. Consumer Staples, Industrials and Financials trailed the broader market.

Performance Overview:

The Target Fund underperformed the benchmark in January by returning -3.6%, net of A2 fees, compared to the -1.7% return for the index.

During the month, the top relative detractor to performance was mainly due to stock selection within the banking industry. Additionally, exposure to IT Services companies also detracted on a relative basis.

Stock selection within the thrifts and mortgage finance industry was the top relative contributor to performance. Additionally, stock selection within capital markets contributed on a relative basis.

Stocks:

Banco do Brasil was the largest relative detractor in January. The stock suffered from the continued impact of COVID in LatAm. Additionally, the CEO announced plans for branch closures and staff reductions, which increased uncertainty for the stock.

Provident Financial was another relative detractor as the stock was negatively impacted by the announcement of extended lockdown measures in the UK due to COVID.

Capital One was the top relative contributor during the month. The company announced better than expected earnings and a repurchase program of up to \$7.5bn USD.

SVB Financial was also a top relative performer. The stock delivered very strong earnings which were 91% above consensus estimates.

Changes:

There were multiple stock level changes during the month.

The Target Fund participated in the IPO of Affirm holdings. The US-based company offers a point-of-sale solution that allows consumers to pay for purchases in fixed amounts through "buy now, pay later" and instalment loan product offerings.

The Target Fund participated in the IPO of Patria, a Latam private equity firm based in Brazil. The Fund Manager believes the company can benefit from secular tailwinds as alternative investments in the region grow. The valuation of the stock remains attractive when factoring in strong growth and margins.

The Target Fund entered a new position in Alight via a SPAC PIPE. Alight is a leading healthcare, benefits, and payroll services provider. The Fund Manager believes the company is well positioned to drive higher growth, especially in their BPaaS (Business Process as a Service) segment, and valuation looks attractive.

The Target Fund also entered a new position in Payoneer, a global payments company focusing on small businesses and digital marketplaces, via a merger with the FTAC Olympus SPAC. The Fund Manager believes the company is well positioned to benefit from the growth in e-commerce and valuation looks attractive.

The Target Fund sold the position in Banco do Brasil and entered a new position in Bradesco. Bradesco, a private bank in Brazil, is similar to Banco do Brasil but the Fund Manager believes Bradesco is more attractive investment from a fundamental standpoint.

The Target Fund also trimmed exposure to some strong performers in the portfolio due to heightened valuations.

Outlook and Positioning:

The Fund Manager sees a strong economic recovery in 2021 if the COVID-19 virus is under control. This should be driven by pent up demand as well as a remarkable combination of monetary and fiscal support. The Fed and other central banks around the world have cut policy rates to historically low levels and expanded quantitative easing to an extent not witnessed before. More importantly, governments have embarked on the

most aggressive fiscal expansion that they have seen.

The Target Fund is tactically positioned to benefit from a recovering economy via its overweight exposure to undervalued consumer credit companies in developed markets which are not particularly rate sensitive.

The Fund Manager sees a continued rally in the equity market driven by the potent combination of economic recovery, fiscal expansion, and ultra-low interest rates.

The Target Fund is tactically underweight developed market banks as, broadly speaking, revenue growth will be subdued on the back of lower margins (particularly US\$ based banks driven by lower rates) and anemic loan growth.

Structurally, the Fund Manager is overweight FinTech due to faster top line growth with less earnings cyclicality driven by secular digitalization trends and the forecast of longer-term disruption.

The Fund Manager is also structurally overweight Emerging Markets due to cheap valuations, faster top line and bottom-line growth and long-term structural growth associated with financial inclusion.
