**INVESTMENT OBJECTIVE AND STRATEGY**

The Fund seeks to achieve income and long-term capital growth by investing all or substantially all of its assets in a collective investment scheme that invests primarily in global debt securities and equities.

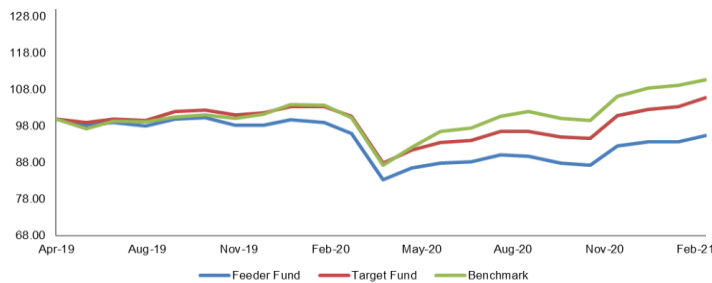

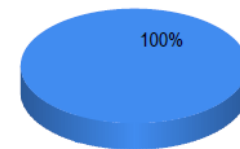

## OUTLOOK AND STRATEGY

(from the JPMorgan Multi Income Fund Monthly Commentary dated February 28, 2021)

**Markets** - Global equities rallied in February, supported by declining COVID-19 cases, progress in vaccine rollouts and better-than-expected economic indicators. However, towards the end of the month stocks pared some of their gains as fears of higher interest rates and inflation intensified. The flash US purchasing managers' index (PMI) for February was strong.

**Helped** - Global equity, Emerging Market Equity, Real Estate Investment Trusts (REITs), High Yield and European Equity.

**Hurt** - Global Government Bonds and Investment Grade Credit.

### Month in review

The S&P 500 Index® reached record highs, supported by optimism over economic revival and better-than-expected quarterly earnings data. Against this backdrop, Global high dividend yielding stocks and Europe high yielding stocks returned 1.4% and 0.3% respectively in local currency terms. Emerging market equities returned 1.0% in local currency terms. Elsewhere, Global REITs rose by 4.0% and infrastructure equity fell by 0.9% during the month.

With markets already pricing in higher inflation expectations, the US yield curve is steepening. The 10-year Treasury yield ended the month at 1.42%. Fixed income markets experienced heightened volatility and as a result government bonds detracted from performance during the month. High yield allocations were additive to performance, while investment grade and emerging market debt allocations detracted. The Fund Manager's non-agency securitized allocation delivered marginal negative returns.

The Fund Manager's hybrid allocation, preferred equities, contributed negatively whereas convertible bond allocation was additive to performance.

### Looking ahead

The risk of a return of inflation in mid-2021 is fueling a trend of rising yields. While the Fund Manager predicts inflation to increase given low base effects, they do not predict inflation to stay elevated at contra-productive levels over the medium term.

High dividend versus growth rotations is likely to continue as we progress towards the end of the pandemic. This will be supported by rising commodity prices and rising yields, which particularly benefit their equity allocation. The Fund Manager continue to favor low-duration, high-carry bonds, which are less affected by the rising-yield environment
