INVESTMENT OBJECTIVE AND STRATEGY

The objective of the Fund is to maximize income and achieve higher returns compared to regular bank deposits while preserving capital by investing in a portfolio of very liquid, fixed-income instruments and maintaining an average portfolio duration of 1 year or less.

CLIENT SUITABILITY

A client suitability process shall be performed prior to participating in the Fund to guide the prospective Investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

The ATRAM Peso Money Market Fund is suitable only for investors who:

- have a conservative risk profile
- give prime consideration to high liquidity and capital security
- have a short term investment horizon
- are seeking better returns compared to time deposit





OUTLOOK AND STRATEGY

Inflation for August printed below market expectations ranging 2.60-3.30%, coming out at 2.40%. The primary drivers for the print were attributable to lower than expected increases in the price indices of clothing & footwear (+1.90%) restaurants & misc. services (+2.30%) and food (+1.80%).

In September, the Bangko Sentral ng Pilipinas (BSP) held the policy rate as expected at 2.25%. However, they revised GDP estimates for the third quarter downwards to -9.0% (from -6.5%), as well as the inflation estimate for 2020 to 2.30% (from 2.60%). The BSP has begun issuing bills, issuing Php 20 billion worth of the 28-day bill. Despite its limited scope, we see continued BSP bill issuance to affect liquidity conditions. Potential inclusion of Trust and Investment Management Accounts (IMA) in its scope could potentially improve money market instrument yields, as these instruments directly compete with Current Account and Savings Account (CASA) funding of the banks.

To date, recent policies are very supportive in nature to provide economic cushion to the economy. However, effectivity in policy has also affected interest rates offered by the banks due to excess low cost funding from the liquidity created by the BSP. At the moment, time deposit rates are at their year-lows. The Fund has been primarily utilizing the higher monthly time deposit rates being offered by select institutions while investment in Treasury bills have been supporting liquidity and are meant to improve the overall yield of the Fund. More broadly, the portfolio continues to be mainly invested in various short-term money market placements; however, we see it optimal to reinvest future maturities in select treasury bills where we see yield pick-up with minimal price risk.
